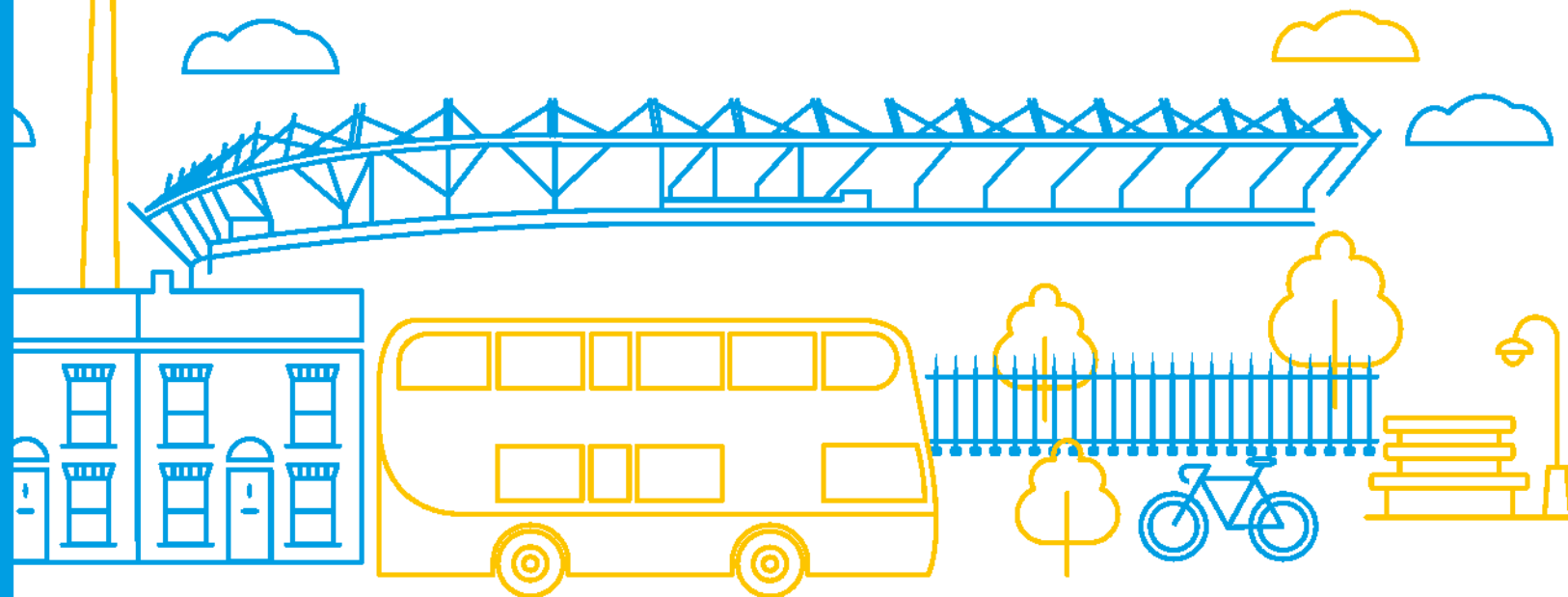

Dublin North Central Gardaí in association with Croke Park & the North East Inner City (NEIC) Programme Implementation Board present the annual Dublin North Central Garda Youth Awards. These awards celebrate outstanding young people between 13 and 21 years of age and recognise the good work being done by young people throughout the communities of Dublin North Central.

Awards will be considered for nominated young people who by their presence make their communities a better place to live.

There will also be an award for groups of two or more young people whose combined efforts have contributed positively to their communities. All nominees and group members should be between 13 and 21 years of age. The Dublin North Central Garda Division covers Mountjoy, Fitzgibbon Street, Bridewell and Store Street Garda Stations.

As much information as possible should be supplied by nominators in respect of nominees and why you think they deserve an award. A seconder is required for each nominee.

### Rules of the Competition:

1. Awards are confined to those young people who are aged between 13 and 21 years of age on 31st December 2023.
2. Permanent residence of the young person must be in the Garda Division in which they are nominated.
3. Awards are confined to individuals and groups of two or more people.
4. Judges decision is final.
0. The Judging Panel will decide upon one nominee in each category to go forward to represent the Division at the National Garda Youth Awards.
5. Any member of the public may nominate anyone whom they feel deserves an award.
6. Nominations may be submitted by family members or relatives.
7. Previous award winners are not eligible.
8. Forms must be signed by a nominator and co-nominator.

## AWARD CATEGORIES

All categories are for young people aged between 13 and 21 years.

### INDIVIDUAL AWARD:

Making a positive contribution to their community, making it a better place to live.

### GROUP AWARD:

Groups of 2 or more, making a positive contribution to their community, making it a better place to live.

### SPECIAL ACIEVEMENT AWARD:

Overcome difficult circumstances, defied all the odds, and whose commitment deserves recognition.

### COMMUNITY SAFETY AWARD:

Through a crime prevention or safety initiative / innovation, have made their community a safer place to live.
